It was noted that for special needs st udents this is crucial. In the discussion around grandfathering students who currently attend ECCS, it was noted this is the right thing to do.

quired, when very little change may enn that the Board wanted to receive public comment and ensure that everyone had an opportunity to present their views. Rick noted that the Board of Truste es operates in a transparent and fiscally responsible fashion. It is crucial to include our Catholic stakeholders (including Parents and our Communities).

A discussion on the Boundary Map took pl ace and it was determined that the North East Tri-Board Student Transportation Co nsortium would work out some scenarios and run some mock bus runs to determine timing and costs for proposed Boundary changes.

### Boundary Review Committee Recommendations:

- 1. NCDSB would grandfather all current stud ents and future siblings that attend ECCS.
- 2. NCDSB support a boundary change in the Latchford South and Lorraine Valley areas to allow students living in these areas to attend St. Patrick Catholic School effective 2014 (see attached Map).

Glenn thanked everyone for their time and commitment to the Boundary Review Process and for their input and adjourned the meeting.
