#### 2.0 Qualifications

- 2.1 A student is qualified to serve as Student Trustee if they are
  - a) a Canadian citizen;
  - b) a full-time student in the senior divisio(grade 11 and 12).

### 3.0 Attendance and Participation

- 3.1 The Student Tustees will participate in the public meetings of the Board.
- 3.2 The Student Trustesearenot to be present at a meeting that is closed to the public under clause 207 (2) (b) of the ducation Act
- 3.3 The Student Trusteemay participate in meetings of the Board in person, via teleconference, videoconference, or other electronic means.
- 3.4 The Student Trusteeshall resign from the position if three consecutive meetings are missed without authorization.
- 3.5 The Student Trusteeshall benon-voting membes and act in concert with other elected Trustees to examine and discuss issues leading to a vote at regular public meetings of the Board.
- 3.6 The Student Trusteeshall follow the normal process of dealing with complaints, questions or suggestions regarding a school or service by advising the Director of Education.
- 3.7 The Student Trusteearenot entitled to move a motion but arentitled to suggest a motion on any matter at a meeting of the Board or of one of its committees on which a Student Trustee sits.

#### 4.0 Responsibilities

- 4.1 The Student Trustesshall act in accordance with the Bayws and Rules of Order of the Board.
- 4.2 The Student Trusteeshall act on behalf of the Board only where authority has been

#### 7.0 Honorarium

- 7.1 The amount of the honorarium is \$2,500 for each complete year that the student holds office.
- 7.2 If a student hold office for a portion of a year, \$2,500 prorated according to the portion of the year the student holds office.

# 8.0 Resources and Training

- 8.1 The Student Trustesshall be reimbursed for outf-pocket expenses in connection with carrying out the responsibility as a Student Trustee in accordance with the Board policy for Trustees.
- 8.2 The Board of Trustees, via the Director of Education, shall provide an orientation session and ongoing support as needed throughout the termoffice
- 8.3 Professional development opportunities will be afforded to the Student Trustage provided to other Trustees.
